Retiring AEA Members are asked to complete this form in order to continue as a retired member after current membership terminates. Upon retiring and in accordance with state law, the balance of membership dues for the year ending August 31 will be deducted from the last paycheck. Current membership will terminate on August 31 and deductions for retired dues will begin. **Retired dues deductions begin immediately for those who are not current AEA members.**

You may add a contribution to The NEA Fund for Children and Public Education in addition to the Membership Dues.

If you signed for monthly deductions for membership dues on the other side, you may sign below to add fifty cents per month to that deduction for the purpose of contributing to the NEA Fund for Children and Public Education.

The National Education Association Fund for Children and Public Education collects voluntary contributions from Association members and uses these contributions for political purposes, including, but not limited to, making contributions to and expenditures on behalf of friends of public education who are candidates for federal office. Contributions to the NEA Fund for Public Education are voluntary: making a contribution is neither a condition of employment nor membership in the Association, and members have the right to refuse to contribute without suffering any reprisal. Although the NEA Fund for Children and Public Education requests an annual contribution of \$15, this is only a suggestion. A member may contribute more or less than the suggested amount, or may contribute nothing at all, without it affecting his or her membership status, rights, or benefits in NEA or any of its affiliates. Contributions or gifts to The NEA Fund for Children and Public Education are not deductible as charitable contributions for federal income tax purposes. Federal law requires political committees to report the name, mailing address, occupation and name of employer for each individual whose contributions aggregate in excess of \$200 in a calendar year. Federal law prohibits The NEA Fund for Children and Public Education from receiving donations from persons other than members of NEA and its affiliates, and their immediate families. All donations from persons other than members of NEA and its affiliates, and their immediate families, will be returned forthwith.
