While he personally paid to have the monument built, he placed it in the Supreme Court under his authority as the administrator of courts. Chief Justice Moore believes that he is required to recognize the sovereignty of the Judeo-Christian God over government and civil laws. A Federal Court Judge in Alabama and a Three Judge Federal Appeals Court in Georgia ordered Chief Justice Moore to remove the monument because the U.S. Constitution prohibits the state from establishing or favoring one religion over another. Chief Justice Moore refused to remove the monument. The U. S. Supreme Court refused to intervene in the lower court orders. Do you believe that Chief Justice Moore should:
